Information on the exercise of the right of withdrawal

You have the right to withdraw from the purchase contract within 14 days without mentioning the reason.

The period of exercise of the right of withdrawal expired after 14 days from the date of receipt of the goods. If the expiry of the period falls on a national holiday, the right of withdrawal shall be exercised until the date of expiry of that period following the working day (including that).

To exercise your right of withdrawal, a clear message (such as a mail letter or e-mail) of the decision to withdraw from the contract for purchase of goods, must be sent to "VALTEG" Ltd, Kr. Valdemara 69, Talsi, or e-mail: info@talsuriepas.lv within 14 days of receipt of the goods. You may use a model of this withdrawal form, but it is not mandatory if the refusal contains the information on the form.

For the duration of the right of withdrawal to be respected, send the notification of the exercise of the right of withdrawal before the expiry of the right of withdrawal.

Consequences of exercising the right of withdrawal

If you opt out of this agreement, we will repay all payments received from you, including delivery costs (excluding additional costs due to the fact that you have chosen a type of supply other than the cheapest or free standard of delivery offered by us), without undue delay and in any event no later than 30 days from the date on which we are offered. we were informed of your decision to withdraw from this agreement. The repayment will be made using the same means of payment as you used for the original transaction, unless you have expressed explicitly your agreement to do otherwise. In any case, you will not be charged any fee for your own reimbursement.

We can suspend the refund until we have received the goods back and check that they have not been used, damaged or otherwise do not correspond to the status of a new item.

You must return the goods or transfer the goods to the "VALTEG" Ltd, without undue delay and in any event no later than 5 days from the date on which you notified us of your decision to withdraw from this contract. The deadline will be met if you return the goods before the 5-day deadline.

You are only responsible for reducing the value of the goods if the goods were used for other purposes than for identifying the type, characteristics and behavior of the goods. The item must be used for inspection purposes to the extent that it would be possible to do so in the store.

The returned goods must be unused: neither the discs nor the tyres should be assembled and used. Keep all packaging items, goods and purchase documentation, as well as any other accessories that come with the item.
